**1. ELIGIBILITY:** The Sweepstakes is open only to individuals who are (a) a legal U.S. resident of one of the eligible forty eight (48) U.S. states (excludes Florida and New York) or the District of Columbia (“D.C.”); (b) eighteen (18) years of age or older (nineteen [19] years of age or older if a resident of Alabama or Nebraska); and (c) employed by a company located in the United States (including D.C.) and have a company email address that can (and must) be used for entry. Void where prohibited. Employees, officers and directors of HP, Inc. **3. During the registration process you will be required to select which prize you would like to receive if you are selected as the winner. See Section 5 for prize details. NOTE: Only entry submissions containing company email addresses will be considered valid; no personal email addresses allowed. **Limit one (1) entry per person/company email address.**
